In case that bid is submitted by a group of bidders, it must be indicated on the envelope that it is a group of bidders and indicate the names and addresses of all participants in the joint bid.</p> <p>The Bid should be submitted at the address of the Serbia and Montenegro Air Traffic Services SMATSA, Llc., at Trg Nikole Pašića 10, 11000 Belgrade, Republic of Serbia bearing a visible note: "Bid for the Public Procurement of Service - 107/U/19, Training in the field of cost accounting for providing air navigation services (ANS services) – DO NOT OPEN". All bids that arrive at contracting authority address until 10.00 am (CEST) on 02/07/2019 regardless of the method of delivery shall be considered as timely bids.</p> <p>A bid which was not received by the Contracting Authority within the indicated deadline shall be considered untimely.
