All bids that arrive at contracting authority address by 03/10/2019 until 10,00 AM (CET) regardless of the method of delivery shall be considered as timely bids.</p> <p>A bid which was not received by the Contracting Authority within the indicated deadline shall be considered untimely. Untimely bids shall be returned to the bidder unopened, after the bid opening procedure.</p>

Place, time and manner of bid opening:	The bid opening procedure shall be carried out on 03/10/2019 at 10.30 AM (CET) at the address of the Contracting authority, as indicated in the Tender Documents.
Conditions under which bidder representatives may participate in the bid opening procedure:	Bidder representatives that wish to participate in the bid opening procedure must provide written authorizations for participation in the bid opening procedure, directly, at the beginning of the public bid opening procedure.
